# **COMPREHENSIVE DISTRICT IMPROVEMENT PLAN**

## **EXECUTIVE SUMMARY:**

It is the goal of the planning team and the district to have a viable plan which is continuously reviewed for modifications and improvements. The AISD plan focuses on improving student achievement with particular regard to the areas of math, writing, reading, special populations and career/technical.

## **PROCESS SUMMARY:**

AISD approached the planning process in a collaborative and cooperative manner. A district wide and community team was composed of district/school administrators, teachers, FRYSC personnel, and parent/community members. Schools and school councils were represented in the process so the participants would be reflective of the broad range of needs served by the district.

Richard Oppenheimer, Director of Student Achievement, met with the district planning team. Work was assigned to committees by interest and to gain representation from all stakeholders. Their charge was to coordinate, review and update the plan for the calendar year, 2011, taking the framework from the plan currently in place. A needs assessment of overall needs was obtained from each principal by the superintendent and is on file at Central Office. Schools reviewed their biennial targets and as data was collected and analyzed, each school along with the district set priorities. The culmination of this process is evidenced in the plan.

This plan was rewritten for calendar year 2011 to include activities and resources to address current NCLB requirements.

In evaluating the effectiveness of the 2010 improvement plan, it was noted that the district met 71.4 percent on its No Child Left Behind goals targeted at improving proficiency in reading and math for all groups of students for the 2009-2010 school year. Analysis is based on the disaggregation of scores for the district and each individual school. While improvements were made in all areas based on this plan, it is realized that more progress is needed.

Many of the projects initiated as part of the 2010 plan were not fully implemented prior to the 2010 assessment. Several of these have proven to be effective through local and commercial diagnostic evaluations and will be continued as part of the 2011 plan. It is expected that as these programs are universally integrated into the schools, student performance on assessments will rise to match NCLB goals.

Our greatest goal is to take initiatives to strengthen the classroom and school communities to build a greater connection between each school and its students. In this way the district may foster and promote students' development intellectually, emotionally, and socially.

Implementation and Impact Checks will be conducted periodically with reports being made to the Board of Education.
